### Menacing Arrest

ON JANUARY 8, 2012 AT 1100 PM, PATROLS RESPONDED TO THE GREENBUSH STATION APT'S FOR A REPORT OF SEVERAL PEOPLE FIGHTING IN THE PARKING LOT.

WHILE ENROUTE TO SAID CALL OFFICERS RECEIVED ADDITIONAL INFORMATION THAT A GUN MAYBE INVOLVED. AS PATROLS APPROACHED THE SCENE SEVERAL INDIVIDUALS RAN INSIDE ONE OF THE APARTMENT BUILDINGS.

ALL PARTIES WERE SECURED AND INTERVIEWED BY OFFICERS. ALL PARTIES GAVE CONFLICTING INFORMATION ABOUT WHO BRANDISHED THE HANDGUN. AFTER ALL PARTIES WERE SECURED OFFICERS LOCATED A HANDGUN LAYING ON THE GROUND A SHORT DISTANCE AWAY FROM WERE THE INITIAL CONFRONTATION HAD OCCURRED.

OFFICERS SECURED THE HANDGUN AND CLEARED THE WEAPON. THE HANDGUN WAS A BRYCO ARMS MODEL JENNINGS NINE WHICH WAS LOADED WITH (1) 9MM BULLET AND THE MAGAZINE WAS MISSING. THE SERIAL NUMBER ON THE GUN HAD BEEN DRILLED AND WAS UNREADABLE. ALL INFORMATION ON PARTIES INVOLVED AND WITNESSES WERE OBTAINED AND ADDED TO CASE FILE.

SEVERAL HOURS LATER, AFTER A LENGTHY INVESTIGATION ONE SUBJECT WAS ARRESTED.

ARRESTED WAS KENNETH VAUGHNS, AGE 29 OF EAST GREENBUSH. HE WAS CHARGED WITH:

- MENACING 2<sup>ND</sup> DEGREE
- CRIMINAL POSSESSION OF A WEAPON 3<sup>RD</sup> DEGREE
- CRIMINAL POSSESSION OF A WEAPON 2<sup>ND</sup> DEGREE
- RECKLESS ENDANGERMENT 1<sup>ST</sup> DEGREE

THE DEFENDANT WAS PROCESSED AND ARRAIGNED BEFORE JUDGE SCHILLING AND REMANDED TO THE RENSSELAER COUNTY JAIL ON \$75,000 CASH / \$100,000 BOND BAIL. SUBJECT IS DUE BACK IN COURT ON JANUARY 13, 2012
